## **New Washington State Law starting Fall 2025:**

The new Engrossed Substitute Senate Bill 5814 requires vocational schools to charge sales tax for their services. The rate for sales tax in Seattle is currently a combined 10.35% (state rate of 6.5% plus the local rate of 3.85%) and is subject to change quarterly. All deposits and tuition will have this tax applied as indicated.

## **Programs Offered at The International Stunt School:**

The International Stunt School offers two classes each summer. All students must take the Stunt Performer Course before attending the Aerial Intensive Course. The Aerial Intensive Course can be taken immediately following the Stunt Performer Course or in any year following attendance to the Stunt Performer Course.

### **Stunt Performer Course:**

- Deposit: \$1103.50 total (\$1000.00 + \$103.50 sales tax)
- Tuition Balance: \$4304.65 (\$3900.00 + \$403.65 sales tax)
- 150 hours of training (18 days, 8-9 hours per day)
- Introductory meeting: July 12, 6:30 pm to 9:00 pm
- Class begins: July 13, 2026
- Class ends: August 1, 2026
- Days off: July 18, July 24
- Hours: 9:00 am to approximately 6:00 pm in Week 1 and 2. 12:00 pm to approximately 9:00 pm in Week 3. One-hour daily meal break with several water breaks.
- Applicants need no prior experience

The Stunt Performer Course provides students with an essential assortment of skills and knowledge to those pursuing careers as professional stunt performers or as actors who want to perform their own stunts. Detailed instruction is provided in the following areas: Foot Falls & Rolls, Stair Falls, Western Combat, Martial Arts, Weaponry, Stunt Driving, Fire Burns, High Falls, Air Ram, Mini Tramp, Wire Work, Ratchet, Rappelling, Parkour, and Acting the Action. Students will learn and practice all disciplines in class. All film fighting is performed for camera and reviewed for critique. Additionally, one complete day is dedicated to discuss the business side of being a stunt performer. This is one of the most valuable aspects of the training, as students will learn how to get hired and how to effectively advance their careers. These meetings will cover such topics as: Resumes, Joining SAG-AFTRA, Networking, and Working On Set. A certificate of completion will be issued to graduates.

### **Aerial Intensive Course:**

- Deposit: \$441.40 total (\$400.00 + \$41.40 sales tax)
- Tuition Balance: \$1324.20 total (\$1200.00 + \$124.20 sales tax)
- 50 hours of training (6 days, 8-9 hours per day)
- Class begins: August 3, 2026
- Class ends: August 8, 2026
- Days off: None

- Hours: 12:00 pm to approximately 9:00 pm with one-hour dinner break and water breaks.
- Applicants to the Aerial Intensive are required to have attended the International Stunt School's Stunt Performer Course at any time before this class begins.

The Aerial Intensive is the optional follow-up class to the Stunt Performer Course and offers advanced training in several different aerial skills. The aerial techniques of each student will be refined and strengthened for better technique in High Falls and on the Air Ram. Similarly, Ratchet will explore several types of harness pulls for different effect, while Rappelling will teach a variety of zone entry and rope work techniques including Australian rappels. Gymnastic techniques, both into a foam pit and on a trampoline, will be utilized to further aerial skills. The bulk of the training will focus on "Wire Work". Students will explore both the physical performance skills and technical application of wire rigs as they pertain to the stunt industry. New and varied rigs are assembled each day and participants are taught the theories, terminology, rigging, safety considerations, and aerial skills that allow a pull team and talent to create the look of effortless and dynamic acrobatic movement on screen. There will be daily hands-on experience with harnesses, spreader bars, pull lines, tag lines, mechanical advantage and disadvantage, knots, splicing, and all the various hardware and synthetic ropes associated with wire effects. A special unit of instruction is also dedicated to performance on aerial silks and rings.

## **School Calendar and Class Schedules**

Class times and/or locations may be subject to change in accordance with the classes being offered. Ample notice will be given to the students by the coordinators.

## **Tuition and Additional Costs**

Students will need to meet all financial responsibilities before a Certificate of Completion will be issued. Deposits are due at the time of application and the tuition balance is due the day before training starts.

### **Stunt Performer Course:**

Students may want to purchase some recommended pads from a sports equipment store, but this cost is entirely optional.

Students wishing to participate in a fire burn will need to purchase expendable clothes, preferably from a 2<sup>nd</sup> hand store, as directed by the staff. Suitable clothes tend to cost about \$50.

## **Facilities**

The International Stunt School takes place in the two largest training rooms in Hutchinson Hall on the University of Washington campus. Floor mats are utilized during all ground work and supplemental mats and pads are used as the training dictates. Outside activities (fire burns, precision driving, etc.) will take place at the auxiliary locations and rain shelters are provided as necessary. Indoor activities at the auxiliary location will take place on a standard gymnastic sprung floor. Lavatories and adequate parking are available at all locations and all are ADA accessible facilities with handicapped ramps and lavatories. Reasonable accommodation will be provided at the request of the student. All high-profile stunt equipment (air bags, air ram, ratchet, rigging, etc.) are top-of-the-line and manufactured by industry professionals. Each piece is factory tested, rated for the stunt industry, and inspected continually before and during use. Most days, students will be broken into two or three groups to learn different disciplines. The maximum class size for the Stunt Performer Course is 54 and the maximum student/teacher ratio is 27 to 1. The maximum class size for the Aerial Intensive Course is 27 and the maximum student/teacher ratio is 9 to 1.

## **Entrance/Admission Requirements**

1. Applicants must be a minimum of 18 years of age.
2. Applicants must be in good physical condition, enabling them to fulfill a demanding physical training regimen. A recent full-body photo is requested as well as a written

document (resume or other) outlining previous and current physical pursuits and/or professional work.

3. Applicants must possess a High School Diploma, a General Education Development (GED) Diploma, or equivalent (if participant is coming from outside the United States).
4. Applicants must submit the required deposit in conjunction with their application via email or mail and pay the balance of their tuition by the day before the first day of training, or have made arrangements with the school administrators for payment.
5. Applicants to the Aerial Intensive must have previously taken the Stunt Performer Course.

Participants are encouraged to carry their own health insurance. Temporary medical insurance can be purchased from insurance companies before the training starts if necessary.

The International Stunt School does not discriminate against students or potential students on the basis of race, creed, color, national origin, sex, veteran or military status, sexual orientation, or the presence of any sensory, mental, or physical disability or the use of a trained guide dog or service animal by a person with a disability. The International Stunt School acknowledges that information pertaining to an applicant's disability is voluntary and confidential, and will be made on an individual basis. All inquiries about accommodations should be made to the Head Administrator upon registration of the program. If this information is presented, the International Stunt School will reasonably attempt to provide an accommodation to overcome the effects of the limitation of the qualified applicant. Due to the overt risk associated with stunt training, any applicant with a disability who requests reasonable accommodation must provide medical documentation before the session begins showing that the applicant possesses the physical and mental capacity to safely participate in the training.

### **Attendance Requirements**

1. Students must make every effort to be in class ready to begin at the designated start time. The school encourages students to treat 15 minutes early as "on-time" in preparation for working in the film industry.
  2. If a student must be absent or late for class, it is his responsibility to inform the School Coordinator so it can be recorded.
  3. Excessive tardiness will be subject to review by the school administrator and may be counted as absences.
  4. Certificates of completion for the Stunt Performer Course cannot be awarded to students whose absenteeism exceeds four or more days in the first two weeks of the training, or failing to participate in three or more disciplines in the third week.
  5. Students should meet with the school coordinator to see if time, instructors, and resources can be spared to revisit missed material. Such instances are extremely unlikely and often impossible (particularly during the third and fourth week).

## **Religious Accommodation**

The International Stunt School will make good faith efforts to provide reasonable religious accommodations to students who have sincerely held religious practices or beliefs that conflict with a scheduled course/program requirement. Students requesting a religious accommodation should make the request, in writing, directly to their instructor with as much advance notice as possible. Being absent from class or other educational responsibilities does not excuse students from keeping up with any information shared or expectations set during the missed class. Students are responsible for obtaining materials and information provided during any class missed. The student shall work with the instructor to determine a schedule for making up missed work.

Examples of religious accommodations may include: condensed review of missed material with relevant equipment if possible; rescheduling performance of class material; or release of participation requirement for a specific discipline.

## **Code of Conduct**

The following conduct is required of all students:

1. Students must always be alert and exercise caution in any class as to the potential for injuries or mishaps which are present in any stunt training.
2. Report all injuries and/or accidents to the workshop coordinator or the class instructor so necessary measures can be taken by the staff to aid the student.
3. DO NOT perform or be coerced into performing any stunt with which you are not comfortable. It is important that you know your limitations. This is NOT a school for “dare devils.” This will not reflect upon your certificate of completion and will only be respected.
4. DO NOT coerce or goad anyone else into performing a stunt in the class environment. Support is always welcomed and an important part of the “team” spirit, but badgering, humiliation, and assaults on a fellow student’s ego will not be tolerated.
5. At all times the instructors have final say as to whether a student is allowed to perform a skill at a given level. Constructive discussions concerning this are tolerated but may have to wait for the appropriate time. Arguments are never tolerated.

The following conduct is unacceptable and will NOT be tolerated:

1. All forms of bias including race, ethnicity, gender, disability, national origin, and creed as demonstrated through verbal and/or written communication and/or physical acts.
2. All forms of harassment and coercion, including verbal, physical, sexual, psychological, and discriminatory harassment.
3. Any physical assaults or verbal threats upon a colleague or an instructor.
4. All types of proven dishonesty, including cheating, plagiarism, knowingly furnishing false information to the institution, forgery, and alteration or use of institution documents with intent to defraud.
5. Intentional disruption or obstruction of teaching, administration, meetings and programs,

disciplinary proceedings, or other school activities.

6. Theft or damage to the school premises and equipment or damage to the property of a colleague or an instructor.
7. Acts of criminal behavior that place any person in imminent danger.
8. Violation of the law. This includes, but is not limited to, the use of alcoholic beverages or dangerous controlled substances.
9. Attending class while under the effects of alcohol, cannabis, or illicit drugs.
10. Reckless behavior on or around any of the stunt and safety equipment. This includes reckless driving with the vehicles.
11. Improper behavior inside or outside the classroom that undermines or compromises the integrity of the International Stunt School and/or its staff and student body. This includes unethical use and distribution of video.

---

### **Conditions for Dismissal**

Students may be dismissed from the school by the school administrators for not adhering to the school's rules, regulations, policies, and code of conduct (see above).

The school coordinator will notify the student in writing should it become necessary to dismiss the student. The dismissal letter will contain the date and the reason for dismissal. It is the responsibility of the dismissed student to notify the appropriate lending institution if the student has a student loan or is receiving financial aid. Tuition will be refunded according to the school's refund policy.

---

### **Re-entry Policy**

Students dismissed from the school who request re-entry must put the request in writing to one of the school administrators. In cases where the student was dismissed due to unacceptable conduct, the student may have to meet with an administrator before re-entering the school. The decision of the administrator is final and the student will receive a letter within five business days stating the decision.

---

### **Student Grievance-Complaint/Appeal Process**

Nothing in this policy prevents the student from contacting the Workforce Board (the state licensing agency) at 360-709-4600 at any time with a concern or a complaint. Students who have a complaint or who would like to appeal a dismissal must request in writing an appointment for an interview with one or more of the school administrators. The written request should include the following information:

1. Student's full name and current address.

2. A statement of the concern including dates, times, instructors, and if applicable, other students involved.
3. Date of complaint letter and signature of the student.
4. Three dates in which the student would be available for a meeting with the school administrator. These dates should be within 10 business days of the complaint.

A school administrator will notify the student in writing of the appointment date in which the concerns or appeal will be addressed. Every effort will be made to bring an amicable closure to the concern. Should it be necessary, a panel of instructors will hear the concerns and will be asked to assist in bringing a resolution to concerns and/or appeals. The student will be notified in writing within five business days of the outcome of the meetings. Should the contract be canceled by either the student or the school the last date of attendance will be used as the date to calculate any refund in accordance with the school's refund policy. Nothing in this policy prevents the student from contacting the Workforce Board (the state licensing agency) at 360-709-4600 at any time with a concern or a complaint.

### **Grading System**

Students will be evaluated on a Pass/Fail system. A Pass shall be given to students who complete the course in a satisfactory manner without exceeding the maximum number of allowed absences or missed disciplines. A Fail will be given to students whose overall work is unsatisfactory for the stunt industry or to any student who exceeds the maximum number of allowed absences or missed disciplines. Students will be notified of status at the end of the training session.

---

### **Credit for Previous Training**

Students wishing to receive recognition for previous training must show proof of previous training. The student will be asked to perform examples of the discipline in question to the satisfaction of the instructor or school coordinator. In some instances, video recordings of skills will be allowed for consideration.

---

### **Educational Credential**

Students who graduate the program with a Pass will be given a Certificate of Completion and granted a membership into the United Stuntmen's Association. This acknowledges that the student is recognized by the United Stuntmen's Association to have the basic skills, comprehensive understanding, and professionalism required to work in the stunt industry.

---

### **Incomplete Grades**

Incomplete grades are given when a student is unable to complete a course because of illness, injury or other serious problems. Students will be given the opportunity to return to the following year's training to repeat only those disciplines that were missed. If a student does not make arrangements to return to the following year's training, a failure grade will be given.

---

### **Withdrawing from School**

Students must prepare a written notification and submit it to the school director. This document must contain the student's name, address, and date. All financial obligations on the part of the school and the student will be calculated using the last recorded date of attendance.

---

### **Student Records**

Student records will be maintained by the school for 50 years or until the school closes. If the school closes, records may be forwarded to the Workforce Training and Education Coordinating Board. Students may request copies by writing the school. Student records are available for review by the student at any time.

---

### **Financial Aid Assistance**

The International Stunt School is not accredited by the Department of Education and therefore not authorized to offer Federal Financial Aid.

---

### **Cancellation and Refund Policy (Compliance with WAC 490-105-130)**

1. Should the student's enrollment be terminated or should the student withdraw for any reason, all refunds will be made according to the following refund schedule.
2. The school must refund all money paid if the applicant is not accepted. This includes instances where a starting class is canceled by the school.
3. The school must refund all money paid if the applicant cancels within five business days (excluding Sundays and holidays) after the day the contract is signed or an initial payment is made, as long as the applicant has not begun training.
4. The school may retain an established registration fee equal to 10 percent of the total tuition cost, or \$100, whichever is less, if the applicant cancels after the fifth business day after signing the contract or making an initial payment. A "registration fee" is any fee charged by a school to process student applications and establish a student record system.
5. If training is terminated after the student enters classes, the school may retain the registration fee established under #3 above, plus a percentage of the total tuition as described in the following table:

6. When calculating refunds, the official date of a student's termination is the last day of recorded attendance:
    - a. When the school receives notice of the student's intention to discontinue the training program;
    - b. When the student is terminated for a violation of a published school policy which provides for termination; or,
    - c. When a student, without notice, fails to attend classes for 30 calendar days.
  7. All refunds must be paid within 30 calendar days of the student's official termination date.

## **Placement Assistance**

The International Stunt School does not currently offer placement assistance. However, a few representatives from live stunt shows are invited to visit near the end of the Stunt Performer Course to observe and make contact with potential new hires. Contact information for the hiring personnel of these companies will be made available. The International Stunt School cannot guarantee employment.

### **DAVID BOUSHEY**

Founder of the United Stuntman's Association. Founder of the Society of American Fight Directors. Inductee into the Hollywood Stuntmen's Hall of Fame. Recipient of the Los Angeles Critics Award for Best Fight Choreography: 1981, 1985, 1991. A 40-year professional career as a stunt coordinator and a stunt instructor throughout North America and Europe. Fight Master emeritus.

### **DANIEL FORD-BEAVIS**

ACTRA stunt coordinator with almost 30 years of stunt coordination, performance, and teaching in Canada. BFA in Drama (Acting) at the University of Saskatchewan, and Fight Director with Fight Directors Canada. Extensive experience with high falls, fire burns, car hits, fights to the death, stair falls, and many more. He has taught at the University of Saskatchewan, The Banff Centre, the International Stunt School as well as a variety of workshops in Quebec, Los Angeles, and Atlanta among others.

8 years as owner of the International Stunt School and 22 years as one of its instructors. SAG-AFTRA stunt performer with extensive experience in stunt rigging. 10 years of study and three awards with the Society of American Fight Directors.

20 years as a professional rigger and flyer. ETCP Certification in Arena Rigging. Has directed flying for television, film and stage. Co-designed flying systems for Seattle Opera and other professional houses. Owner/Director of Stage Flight FX Company. Journeyman member of IATSE. Key rigger for the International Stunt School with 18 years as one of its teachers.

**GREG POLJACIK**

SAG-AFTRA stunt performer and fire burn coordinator based in Chicago. 14 years as instructor for the International Stunt School. Member of LBP Stunts Chicago, owner of Sweet Spot of the Flame LLC (specializing in fire burns), and Gravity and Momentum LLC (maker of blood effects). Also works as a neuroscience researcher specializing in risk and high-performance athletes at the University of Chicago.

**WADI JONES**

SAG-AFTRA stunt performer and assistant stunt coordinator with 14 years as a professional teacher in several venues including boxing, mixed martial arts, parkour, break dance, and hip hop. 11 years as an instructor with the International Stunt School. Has toured domestically and internationally in live stunt shows and was in the top 16 of "So You Think You Can Dance" (season 8).

**CHUCK JOHNSON**

Japan's first and only prominent non-Japanese stunt performer, action actor and motion-capture artist, with over 20 years of experience. Chuck has well over 100 international TV shows, films, video games and commercials to date, including GI JOE: Origin of Snake Eyes, Street Fighter 6, Metal Gear Solid V, and many others. Chuck has also been a guest fight choreography instructor for the Society of American Fight Directors' Winter Wonderland Workshop, The International Order of the Pen and the Sword's Paddy Crean Workshop, and currently runs Quiet Flame Productions in Tokyo, Japan. 10 years as instructor with the International Stunt School.

**SARA BEKO**

Sara Beko is stunt performer with a military background and advanced medical training, now in her 4<sup>th</sup> year of teaching at the school. She specializes in rigging/wirework, rappelling, fire safety, and water safety, and has coordinated projects for Billie Eilish, led Travis Scott's Main Stage performance at Coachella, and portrayed Wonder Woman in DC's (now-canceled) video game. Her career includes extensive international stunt work, collaborating with teams worldwide.

**SHANE ALEXANDER**

Martial arts veteran of over 25 years. He has studied, Tae Kwon Do, Kenpo, Hapkido, Judo, American Kick Boxing, and Muay Thai and has taken home multiple medals from many international tournaments. He also founded the first stunt team in San Diego, "The Southern California Stunt Crew". Shane has over 35 movie titles to date and has been a working Stunt Performer since 2018, having won "Best Stunts in a Feature Film" at the International San Diego Film Awards and nominated for two more films.

**ARIEL LEE**

Ariel Lee grew up as a competitive gymnast which led into 18 years of experience teaching gymnastics, cheerleading, tumbling, and dance. She has translated these skills to on screen stunts, with credits for multiple creature characters in movies, commercials, and tv.
